However I have extensive experience in many equine disciplines, through my work as a sports horse vet and also having been a keen event rider for many years in the UK. I have been an active FEI treating veterinarian for a number of years and also hold a racing NSW veterinary license. Both these jobs involve having extensive knowledge of the rules of competition and racing, drug withdrawal times and their implementation, as well as upholding the governing regulations.

Sport Knowledge and Involvement

I have been very involved in the eventing world in the UK almost all my life as I used to ride competitively. Since my time in Australia (August 2009 onwards) I have been intricately involved in the equine sports horse field as I am a veterinarian with a focus on sports horse performance and rehabilitation. I work closely with a number of top eventing, show jumping and dressage riders, as well as a number of Thoroughbred racing trainers in Randwick. I regularly attend dressage and eventing competitions as the on duty vet and understand the challenges riders face to keep their horses in peak condition, as well as the issues surrounding keeping large groups of horses travelling from different areas healthy and safe. In early 2009 I completed a 5 year specialist training in Veterinary Sports Medicine and Rehabilitation which is the highest level of qualification that can be achieved in this field. This has given me extensive knowledge of all sports horse disciplines and injury diagnosis, management and prevention.
