With support from my committee, introduced the JJD (Jumper Judge Dashboard) online jumping event scoring program with hands-on trialling via the HVSJC where development to suit Australian rules took place before presenting the program to the state. This program is now used Australia wide. In 2015 myself along with a group of individuals, called an ENSW Special General Meeting for the purpose of halting the EA Hendra By-Law after it became apparent that the Hendra vaccine was causing unacceptable damage to the welfare of our horses.
