Important:

1. A Lease Notification will only be accepted where the **Owner & Lessee are current members of EA and to order a performance card both lessor and lessee must remain current throughout lease.**
2. A Lease Notification Form must be forwarded to ENSW within 30 days of the "Start Date"
3. A Lease Notification Form must have indicated a "Start Date" and "Expiry Date"
4. Under all circumstances (including the issue of fines and penalties), the Lessee will be considered the responsible party
5. The horse's original **Certificate of Registration &** current performance cards **must be submitted** with the Lease Notification Form. The Certificate of Registration will be endorsed, and lease details recorded, ENSW will forward the original certificate to the owner and a copy will be sent to the lessee.
6. The ORIGINAL LEASE NOTIFICATION only will be accepted – *no photocopies or faxes.*
7. **It is highly recommended that you have a Legal Lease Agreement (contract) drawn up between both parties to prevent any legal issues at a later date.**
8. Both parties must notify ENSW in writing on early termination of the lease.
