A Lease Notification will only be accepted where the Owner & Lessee are current members of EA and to order a performance card both lessor and lessee must remain current throughout lease. 2. A Lease Notification Form must be forwarded to ENSW within 30 days of the "Start Date" 3. A Lease Notification Form must have indicated a "Start Date" and "Expiry Date" 4. Under all circumstances (including the issue of fines and penalties), the Lessee will be considered the responsible party 5. The horse's original Certificate of Registration & current performance cards <i>must be submitted</i> with the Lease Notification Form. The Certificate of Registration will be endorsed, and lease details recorded, ENSW will forward the original certificate to the owner and a copy will be sent to the lessee. 6. The ORIGINAL LEASE NOTIFICATION only will be accepted – <i>no photocopies or faxes</i>. 7. It is highly recommended that you have a Legal Lease Agreement (contract) drawn up between both parties to prevent any legal issues at a later date. 						

8. Both parties must notify ENSW in writing on early termination of the lease.
